

KuulEats Local Terms of Service

Updated 20.1.21

Kuul Eats Local Ltd (“KuulEats Local”), “we”, “us” and terms of similar meaning) provides the KuulEatsLocal Application and its web site <https://www.kuuleatslocal.com/> (“Site”) and all associated services including online ordering and terminal and marketplace business services and add-ons including third party services and hardware (“KuulEats Local Services”) to you subject to these Terms of Service (“Terms”) and any specific terms agreed between you and KuulEats Local (“Customer Terms”). These Terms and Customer Terms apply to: (i) your use of KuulEats Services; (ii) the use of KuulEats Services by third parties authorised through your KuulEatsLocal account to use KuulEats Services and your User Content (as defined below) through KuulEats Services; and (iii) the use by such authorised users of any additional software, hardware or other services provided, referred, or recommended by us or third parties as part of or for use with KuulEats Services.

Please read the Customer Terms and the Terms carefully before using KuulEats Services. By accessing, using or continuing to use KuulEats Services you agree to be legally bound by the Customer Terms and the Terms and all terms, policies and guidelines incorporated by reference into the Customer Terms and the Terms. If you do not agree with the Customer Terms and the Terms in their entirety you may not use KuulEats Services.

In the Terms, our customers and their staff members to whom they give access to their KuulEatsLocal account are called “Subscribers”, and our customers’ customers who use KuulEats Local Services (for example, to view or use KuulEats Services designed for use by those parties) are called “Customers”. Users of KuulEats Local Services, whether they are Subscribers or Customers, are called “Users”.

KuulEats reserves the right to change or modify any of the terms and conditions contained in the Terms, or any policy or guideline applicable to KuulEats Services, at any time and in its sole discretion. If you do not agree with the changes, you can cancel your account with us by contacting support@kuuleats.com without further obligation effective upon termination or expiry of your current term and the prior KuulEats Terms of Service will remain in force. If you renew your services past your current term, then current KuulEats Terms of Service will apply. Subject to the foregoing and unless otherwise specified, any changes or modifications will be effective immediately upon posting of the revisions on the Site, and your continued use of KuulEats Services after such time will constitute your acceptance of such changes or modifications.

You should from time to time review the Terms and any policies and documents incorporated in them to understand the terms and conditions that apply to your use of KuulEats Services. The Terms will always show the ‘last updated’ date at the top. If you do not agree to any amended Terms, you must stop using KuulEats Services. If you have any questions about the Terms, please email us at support@kuuleats.com.

KuulEats Services are for your own use only. You may not resell, host, publish, lease or provide them in any other way to anyone else, except as expressly permitted by KuulEats Local or under the Customer Terms.

1. Privacy Policy

Please refer to KuulEats Local Privacy Policy, available at [Privacy policy](#) for information on how KuulEats Local collects, uses and discloses personally identifiable information from Users. By using KuulEats Local Services you agree to our use, collection and disclosure of personally identifiable information in accordance with the Privacy Policy. Furthermore, as a Subscriber, you agree to establish and maintain a privacy policy that complies with local laws in your jurisdiction and that is consistent with the KuulEats Local Privacy Policy. You agree that KuulEats Local may collect, maintain and use non- personally identifiable data including User Content in aggregated form for its business purposes, including the improvement and enhancement of its

services and you grant KuulEats Local an irrevocable, perpetual, non-exclusive right to use such data for such purposes including the improvement and enhancement of its services and you grant KuulEats Local an irrevocable, perpetual, non-exclusive right to use such data for such purposes. You warrant that you will comply at all times with the applicable data protection legislation and you will maintain appropriate measures to ensure that the rights of the people to whom the personal data relates are protected. You will also implement and maintain appropriate technical and organisational measures to ensure a level of security appropriate to the risks presented by processing of the personal data, and you must not transfer any personal data outside the EEA without our consent.

If you process any personal data you will follow any instructions we give you in respect of that data which may include activities that assist and enable us to comply with our obligations under applicable data protection laws and you will immediately notify us on becoming aware of any actual or possible data breach. You will indemnify us for any loss, damage, dispute or third party claim incurred by us as a result of your breach.

2. Registration Data; Product Data & Account Security. If you register for an account for KuulEats Local, you agree to (a) provide and maintain accurate, current and complete information as may be prompted by any registration forms on KuulEats Local Services (“Registration Data”); (b) maintain the security of your password/s; (c) maintain and promptly update the Registration Data, and any other information you provide to KuulEats Local, and to keep it accurate, current and complete; and (d) accept all risks of unauthorised access to the Registration Data and any other information or data you provide to KuulEats Local or through the KuulEats Local Services. You are responsible for all activity on your KuulEatsLocal account, and for charges incurred by your KuulEats Local account.

You acknowledge that information about your products will be reproduced verbatim within the KuulEats Local Software. You accept that responsibility for accuracy lies with you. We do not undertake to check, and are not liable for, checking this information on your behalf.

3. Fees; Charges; Taxes Fees and any other charges for the use of KuulEats Local Services are described in the Customer Agreement. They may change from time to time. If they do change, your continued use of KuulEats Local Services after the change indicates your agreement with the new fees and charges after the effective date of the change. Any change to fees and other charges will not be applicable to the billing period in which the change occurs but shall apply to any subsequent renewal. You are responsible for all taxes applicable to the fees and charges in any applicable jurisdiction. All pre-paid license, subscription, or other fees (including professional services such as installation and training) are non-refundable and subject to any additional payment or other terms or conditions provided for in the applicable quotation or order documentation.

4. Ownership, Copyright and Trademarks. In the Terms the content available through KuulEats Local Services, including all information, content, data, logos, marks, interfaces, designs, graphics, pictures, sound files, other files, and their selection and arrangement, is called “KuulEats Local Content”. Content provided by Users, whether they are Subscribers, Customers or other Users, is called “User Content”. For example, data about its Customers and that a Subscriber provides to KuulEats Local is User Content of that Subscriber, data about its payments, products, or operations that a Customer provides to KuulEats Local is User Content of that Customer, and Content that a User enters into any KuulEats Local database is User Content of the User. User Content is that User’s property. KuulEats Local’s only right to that User Content is the limited licenses to it granted in the Terms and as necessary to provide support to end users or to ensure the security of KuulEats Local Services and technology. Other than the User Content, all Content and all software available on KuulEats Local Services or used to create and operate KuulEats Local Services is the property of KuulEats Local or its licensors, and is protected by English and international patent, trademark, and copyright laws, and all rights to KuulEats Local Services, such Content and such software are expressly reserved. All trademarks, registered trademarks, product names and company names or logos mentioned in KuulEats Local

Services are the property of their respective owners. Reference to any products, services, processes or other information, by trade name, trademark, manufacturer, supplier or otherwise does not constitute or imply endorsement, sponsorship or recommendation of them by KuulEats Local.

KuulEats Local may use and shall be the exclusive owner of any feedback, suggestions, improvements or ideas ("Feedback") you provide or have provided to KuulEats Local regarding the KuulEats Local Services. This applies to Feedback provided to KuulEats Local at any time in any format. You assign all intellectual property rights in Feedback to KuulEats Local immediately upon communication of such Feedback to KuulEats Local or its representatives. KuulEats Local may use Feedback for any purpose without compensation or attribution to you and you forever waive and surrender any and all rights in Feedback. If you authorize third parties to access your User Content through KuulEats Local Services, you agree that we are permitted to provide to them the User Content, and also agree that we have no responsibility or liability for their use of such User Content. Any such access shall be governed by any applicable end user or API agreements or terms applicable to such third party and may be subject to fees charged by such third party.

Without limiting the generality of the foregoing, you are responsible for all business continuity, data loss, business interruption, or other risks that may arise out of your use of KuulEats Local Services. KuulEats Local denies, disclaims, and waives any liability for any loss that may occur arising through use of KuulEats Local Services, including, but not limited to, loss of data, business interruption, incorrect calculation of any amount, including taxes or amounts due from your customers, or loss of customer goodwill.

KuulEats Local Services are provided on an "as is" basis. You acknowledge and accept all risks associated with using KuulEats Local Services and release KuulEats Local from any claim or liability in relation thereto.

Your data and User Content is your responsibility. We have no responsibility or liability for it, or for any loss or damage your User Content may cause to you or other people.

5. Your Limited License of Your User Content to KuulEats Local We do not claim any ownership interest or rights in your User Content except as provided for under the Terms, but we do need the right to use your User Content to the extent necessary to provide KuulEats Local Services, now and in the future. Therefore, by posting or distributing User Content to or through KuulEats Local Services, you (a) grant KuulEats Local and its affiliates and subsidiaries a non-exclusive, royalty-free, transferable right to use, display, perform, reproduce, distribute, publish, modify, adapt, translate, and create derivative works from such User Content, in the manner in and for the purposes for which KuulEats Local Services from time to time use such User Content; (b) represent and warrant that (i) you own and control all of the rights to the User Content that you post or otherwise distribute, or you otherwise have the lawful right to post and distribute that User Content, to or through KuulEats Local Services; and (ii) the use and posting or other transmission of such User Content does not violate the Terms and will not violate any rights of or cause injury to any person or entity.

If your User Content is intended for the use of other Users you also grant us and our affiliates and subsidiaries and partners a non-exclusive, royalty-free, transferable right to sublicense such User Content to such Users for their use in connection with their use of KuulEats Local Services in accordance with all applicable privacy laws and regulations.

These licenses from you are non-exclusive because you have the right to use your User Content elsewhere. They are royalty-free because we are not required to pay you for the use of your User Content on KuulEats Local Services. They are transferable because we need the right to transfer these licenses to any successor operator of KuulEats Local Services. Our rights to "modify, adapt, translate, and create derivative works from" are necessary because the normal operation of KuulEats Local Services does this to your User Content when it processes it for use in KuulEats Local Services.

6. Our Limited License of Content to You

KuulEats Local grants you a limited, revocable, non-exclusive, non-sublicensable, non-transferable license to access KuulEats Local Services and to view, copy and print the portions of the Content available to you through KuulEats Local Services for the limited purpose of using KuulEats Local Services as contemplated by the Terms and the Customer Terms. Such license is subject to the Terms, and specifically conditional upon the following: (i) you may only view, copy and print such portions of the Content for your own use as contemplated by KuulEats Local Services; (ii) you may not modify or otherwise make derivative works of the Content, or reproduce, distribute or display the Content except as expressly permitted in the Terms; (iii) you may not remove or modify any copyright, trademark, or other proprietary notices that have been placed in the Content; (iv) you may not use any data mining, robots or similar data gathering or extraction methods; and (v) you may not use KuulEats Local Services or the Content other than for their intended purpose. You may not assist any third party in carrying out these prohibited activities. When you use KuulEats Local Services to publish any menu, online ordering or similar functionality, a KuulEats or KuulEatsLocal logo or similar attribution with link to KuulEats.com or KuulEatsLocal.com will be installed.

Except as expressly permitted above, any use of any portion of the Content without the prior written permission of its owner is strictly prohibited and may result in the termination of the license granted in this Section without notice, and immediate termination of the Customer Agreement and your account with us. Any such unauthorised use may also violate applicable laws, including without limitation patent, copyright and trademark laws. Unless explicitly stated herein, nothing in the Terms may be construed as conferring any license to intellectual property rights, whether by estoppel, implication or otherwise. The license in this Section is revocable by KuulEats Local at any time without notice or warning.

You represent and warrant that your use of KuulEats Local Services and the Content will be consistent with this license and will not infringe or violate the rights of any other party or breach any contract or legal duty to any other parties, or violate any applicable law or regulation.

To request permission for uses of Content not included in this license, you may contact KuulEats Local at the address set out at the bottom of the Terms.

7. Using the KuulEats Local Services and Marketing Services

KuulEats Local Services may include services whereby you or developers or third-parties hired by you use the KuulEats Local Services to market your products and services. This Section contains terms and conditions applicable to your use of the KuulEats Local Services for that purpose, whether you are a Subscriber or other User, including a developer or operator of a website or application (a "KuulEats Local Marketing Initiative") who wishes to use the KuulEats Local Services for the purpose of including Content in your KuulEats Local Marketing Initiative.

If you are a Subscriber and you procure a third-party to develop a KuulEats Local Marketing Initiative for you, this Section applies to your and their use of the KuulEats Local Services, and you are responsible for their compliance with this Section to the same extent as though you were developing the KuulEats Local Marketing Initiative yourself. If you are a services developer and not otherwise a User, your use of the KuulEats Local Services constitutes your agreement to the Terms. We may change the Terms without notice to you by posting new Terms on the Sites. It is your responsibility to review the Sites for changes to the Terms. If you use KuulEats Local Services after new Terms are posted, your use of KuulEats Local Services constitutes your agreement to the new Terms. If you do not wish to be bound by the new Terms, cease your use of KuulEats Local Services.

If you are a services developer supporting a KuulEats Local Marketing Initiative and not otherwise a Subscriber or other User of KuulEats Local Services, the license set forth in this Section applies to your use of the KuulEats

Local Services, and the license set forth in Section 6 does not apply to your use of the KuulEats Local Services. If you are also a Subscriber or other User, the license set forth in Section 6 applies to your use of Content other than the KuulEats Local Services, and this Section applies to your use of the KuulEats Local Services.

KuulEats Local grants you a limited, revocable, non-exclusive, non-sublicensable license to use the KuulEats Local Services as provided by KuulEats Local in the manner permitted by the Terms. Such license does not license any other Content to you, including Subscriber Content. If you wish to use your KuulEats Local Marketing Initiative to display or deliver any Content provided to us by a Subscriber, you must obtain the prior agreement of that Subscriber to that use, by obtaining a license from the Subscriber, in terms of use governing the use by that Subscriber of your KuulEats Local Services Implementation, for your use of that Content. This limited license is subject to the usage restrictions set forth in Section 8, and any further restrictions set out in your terms of use and privacy policy agreed to by the Subscriber.

To minimise the risk of security breaches and technology malfunctions, you agree to use dedicated hardware for KuulEats Local Services. (For example, you will ensure that your employees do not install apps on the iPads; do not use the iPads to surf the web, and such). If you do not use dedicated hardware, we reserve the right to not support your KuulEats Local Services as the other applications may cause conflicts or performance issues with KuulEats Local Services.

8. Other Restrictions on Use of KuulEats Local Services

Any party's use of the KuulEats Local Services is also subject to the following restrictions. You (alone or by assisting or enabling any other party) may not:

- Interfere or attempt to interfere in any manner with the proper workings of the KuulEats Local Services, or create or distribute any KuulEats Local Marketing Initiative that adversely affects the functionality or performance of KuulEats Local Services or adversely impacts the behavior of other applications using the KuulEats Local Services;
- Misrepresent your identity or intentions when communicating with us in relation to the KuulEats Local Services, use the developer credentials licensed to a different individual or entity, allow your credentials to be used by others, or mask your usage of the KuulEats Local Services;
- Use the KuulEats Local Services in association with, or as a component of, any website that in the sole discretion of KuulEats Local is determined to be obscene or otherwise commercially inappropriate;
- Use the KuulEats Local Services for any application that constitutes, promotes or is used in connection with spam, spyware, adware and other malicious programs or code;
- Use the KuulEats Local Services in any manner or for any purpose that violates any law or regulation, any right of any person, including but not limited to intellectual property rights, rights of privacy, or rights of personality, taxation or governmental reporting obligations or other regulatory obligations;
- Replicate, in whole or in part, the "look and feel" of KuulEats Local Services or portion of them;
- Use a combination of visual, design, or functional elements that could reasonably be expected to cause confusion between KuulEats Local Services and your KuulEats Local Marketing Initiative among users;
- Disparage or otherwise negatively represent KuulEats Local Services or do anything that could result in damage or dilution to the goodwill of KuulEats Local and its brands;
- Use the KuulEats Local Services for any application or service that attempts to replace or replicate the essential user experience or functionality of any or all KuulEats Local Services;
- Reverse engineer, decompile or otherwise attempt to extract the source code of KuulEats Local Services or any part thereof;
- Circumvent or render ineffective any IP address-based functionality or restriction imposed by KuulEats Local Services;

- Circumvent technological measures to prevent direct database access, nor manufacture tools or products to that effect;
- Build conversion functionality that converts Content from the KuulEats Local Services to a competing or alternative product or service; or
- At any time you are operating your KuulEats Local Marketing Initiative, solicit, interfere with or endeavour to entice away from us any of our Subscribers or other Users.
- You agree to carefully monitor your use of the KuulEats Local Services and ensure that it remains within reasonable operational limits for both your own server capacity and for ours, when applicable. KuulEats Local has no responsibility to any person for any use or misuse of any Content obtained through the KuulEats Local Services. If you are a Subscriber, you should consider carefully whether you wish to give a KuulEats Local Marketing Initiative services developer access to your Content through the KuulEats Local Services. If you wish to revoke access to your Content through the KuulEats Local Services, you should change your KuulEats Local Services password or revoke authorization of the KuulEats Local Marketing Initiative to your Content. Please contact us at support@KuulEats.com if you need assistance doing this.

KuulEats Local may monitor your use of the KuulEats Local Services for any reason, including but not limited to: quality assurance, the improvement of KuulEats Local products and services, and for verification of your compliance with the Terms. You shall not interfere with such monitoring or otherwise obscure from KuulEats Local any aspect of your use of the KuulEats Local Services. You acknowledge that any use by us of your KuulEats Local Marketing Initiative for such purpose will not constitute our agreement to any terms of use you purport to require us to comply with in such use.

9. Use of Social Media Areas and KuulEats Local Services

KuulEats Local Services may include discussion forums, location-based services, products, pricing, and establishment information, bulletin boards, review services or other forums in which you or third parties may post reviews or other content, messages, materials or other items on KuulEats Local Services (“Social Media Areas”). If KuulEats Local provides such Social Media Areas, you are solely responsible for your use of such Social Media Areas and use them at your own risk. User Content submitted to any public area of KuulEats Local Services will be considered non- confidential. You agree not to post, upload to, transmit, distribute, store, create or otherwise publish through KuulEats Local Services any of the following:

- Any message, data, information, text, music, sound, photos, graphics, code or other material that is unlawful, libelous, defamatory, obscene, pornographic, indecent, lewd, suggestive, harassing, threatening, invasive of privacy or publicity rights, abusive, inflammatory, fraudulent or otherwise objectionable;
- Content that would constitute, encourage or provide instructions for a criminal offense, violate the rights of any party, or that would otherwise create liability or violate any local, state, national or international law;
- Content that may infringe any patent, trademark, trade secret, copyright or other intellectual or proprietary right of any party;
- Content that impersonates any person or entity or otherwise misrepresents your affiliation with a person or entity;
- Unsolicited promotions, political campaigning, advertising or solicitations;
- Private information of any third party, including, without limitation, addresses, phone numbers, email addresses and credit card numbers, unless that third party has expressly consented to such use;
- Viruses, corrupted data or other harmful, disruptive or destructive files;
- Content that is inaccurate, misleading, or unrelated to the topic of the Interactive Area(s) in which such Content is posted; or

- Content that, in the sole judgment of KuulEats Local, is objectionable or which restricts or inhibits any other person from using or enjoying the Interactive Areas or KuulEats Local Services, or which may expose KuulEats Local or its affiliates or its users to any harm or liability of any type.

KuulEats Local has a “zero-tolerance” policy towards unauthorised marketing and spam: you may not use the Social Media Areas or KuulEats Local Services generally to send commercial or other messages to any third-party if those messages are not solicited, authorised or welcomed by the third-party, and in your use of KuulEats Local Services you must comply with all applicable laws, including laws that apply in any jurisdiction to spam and marketing practices, and with any applicable marketing association guidelines on ethical marketing practices.

Any use of the Social Media Areas or other portions of KuulEats Local Services in violation of the foregoing violates the Terms and may result in, among other things, termination or suspension of your rights to use the Social Media Areas and/or KuulEats Local Services.

10. Providing a Reliable and Secure Service

We put a great deal of effort into ensuring that KuulEats Local Services operate on a reliable basis and where applicable provide a secure environment for your data. We use what we believe to be “best-of-class” infrastructure and hosting services and security technologies and services that we believe will provide you with a secure and safe environment. However, no system is perfectly secure or reliable, the Internet, hardware, power sources, and local servers and associated technology are inherently unreliable at times and can be an insecure medium, and the reliability of hosting services, Internet intermediaries, your Internet service provider, servers, databases, access to or use of financial or business records, and other service providers cannot be assured or assumed.

When you use KuulEats Local Services, you acknowledge that you understand and accept these risks, and you accept sole responsibility for choosing to use a technology that does not provide perfect security or reliability. In particular, Subscribers who choose to store the credit card information of their Customers accept these risks to the security of that credit card information. KuulEats Local recommends that no credit card information is stored within KuulEats Local Services. Notwithstanding, when storing credit card information using the KuulEats Local Services directly or using third party services, Subscribers acknowledge that they are aware of, and accept as satisfactory, credit card protection procedures. Ultimately, credit card data is provided by Subscribers and their Customers, and they are responsible for its protection in compliance with all applicable laws and standards.

11. No Responsibility for Third-Party Material

KuulEats Local Services may contain links or references to third-party Web sites (“Third-Party Sites”) and third-party content (“Third-Party Content”) as a service to those interested in this information, including third party suppliers, payment processors and other payment intermediaries that you may use in connection with your use of KuulEats Local Services. You use links to Third-Party Sites and any Third-Party Content or service provided there, at your own risk.

KuulEats Local makes no claim or representation regarding Third-Party Content or Third-Party Sites, and provides them or links to them only as a convenience. Inclusion in KuulEats Local Services of a link to a Third-Party Site or Third-Party Content does not imply KuulEats Local’s endorsement, adoption or sponsorship of, or affiliation with, such Third-Party Site or Third- Party Content. KuulEats Local accepts no responsibility for reviewing changes or updates to, or the quality, content, policies, nature or reliability of, Third-Party Content, Third-Party Sites, or Web sites linking to KuulEats Local Services. When you leave KuulEats Local Services, our terms and policies no longer govern. You should review applicable terms and policies, including privacy and data gathering practices, of any Third-Party Site, and should make whatever investigation you feel necessary or appropriate before proceeding with any transaction with any third party. The provider of any third party service is

solely responsible for that third party service, the content therein, any warranties to the extent that such warranties have not been disclaimed, any training, support or maintenance for the third party services, and any claims that you or any other party may have relating to that third party services or your use of that third party service. You acknowledge that you are purchasing the license to each third party service from the provider of that third party service; KuulEats Local is not acting as agent for the provider in providing each such third party services to you; KuulEats Local is not a party to the license between you and the provider with respect to that third party services; and KuulEats Local is not responsible for that third party services, the content therein, or any warranties or claims that you or any other party may have relating to that third party services or your use of that third party services.

You acknowledge and agree that KuulEats Local and its affiliates are third party beneficiaries of the End User License Agreement for each third party service, and that, upon your acceptance of the terms and conditions of the license to any such third party services, KuulEats Local will have the right (and will be deemed to have accepted the right) to enforce such license against you as a third party beneficiary thereof.

12. Online Ordering and Terminal Business and Online Marketplace

KuulEats Local makes available online ordering and terminal and marketplace business services through the Site to users of KuulEats Local Services for the purposes of enabling you to accept orders for products and services ("Orders") and to facilitate payments between you and persons placing orders via the Site. Orders and payments you accept through the Site are transactions between yourself and the customer placing the order and not with KuulEats Local. By using the online ordering and terminal and marketplace business services you accept that KuulEats Local uses a third party payment provider to arrange payment services to authorise and settle payment for Orders. The payment processor's terms and conditions and privacy policy will govern all payments. KuulEats Local is not the seller of any product or service offered by you and is not a party to any payment transactions.

Where you use on line ordering and terminal business services as part of the KuulEats Local Services:

- A. You must ensure that your products and prices are correct and up to date;
- B. You must provide correct information in accordance with applicable laws and regulations.
- C. You must indicate promptly if you accept or reject the Order and if the Order is to be collected or delivered.
- D. A legal contract will be created between you and your customer for the supply of products and services;
- E. You must check that your customer's debit or credit card is the same as the receipt data for the Order.
- F. You will be responsible for any costs or expenses incurred by KuulEats Local as a result of complaints about your provision of products and services to your customers.

13. Hardware Warranties, Limitation of Liabilities

a) KuulEats Local hereby assigns the manufacturer's warranty (if any) for the hardware to you to the extent such manufacturer's warranty exists and is assignable. b) The manufacturer's warranty (if any, and if assignable) is the only warranty that shall be provided by KuulEats Local with respect to the hardware product. c) KuulEats Local makes no warranties for the hardware product.
